### **Agenda**

The agenda for the meeting included approving minutes from August meeting, discussing Luke Webster's proposal, approve contractor for asphalt repair and landscaping from quotes submitted and review annual meeting procedures and needs.

## **Meeting Discussion:**

- The Board approve the minutes from the August 6<sup>th</sup> meeting.
- Luke Webster shared opinions and concerns from a group of association members with whom he has
  been in communication. He explained to the Board the proposal he wishes to present at the annual
  meeting amending the CCR's with respect to specific wording on trailers, campers, rv's, propane tanks,
  heat pumps, and AC units. The Board is making an adjustment to the agenda to include Luke Webster's
  presentation.
- The Board reviewed four (4) landscaping proposals. The Board accepted the bid from Omar's
   Landscaping 24 visits a year/ to work on the 15<sup>th</sup> & 30<sup>th</sup> of each month @ \$175/month plus tax. The
   agreement will specify month to month service for three months if the association is satisfied, a longer
   agreement will be set. Omar's Landscaping is licensed with WA State and is insured. Lee is contacting
   James to terminate his service.
- Two (2) asphalt proposals were submitted to the Board. The Board agreed on JB Ashpalt as the contractor and that \$6,000 was available for repair/repave of 3 specific areas in the community 1) separation in the roadway before reaching the bend to the culvert on 161<sup>st</sup>; 2) area on far South 159<sup>th</sup> across from lot 118 (vacant lot); 3) area at intersection of 159<sup>th</sup> and driveway of lots 115, 116. Kathleen is contacting Tom at JB to schedule work. Tom indicated that work can begin the week of September 16<sup>th</sup>.
- ACC request approved one (1) house repaint submission.
