## Finance Report:

- Balances

- Front Entrance revamp invoice of \$12,437.40 paid
- Reviewed and approved 1102-H 2017 year tax return
- Still awaiting back dues on lot 116 from new owners

## Old Business:

- 2 Dogs have been regularly entering the community and owner's lots. County confirmed owners are
  outside of Newberg Crest HOA and this has been a regular occurrence. Since the dog's owners are not
  members of the community no action will be taken.
- Compliance self-check will be used this year in place of Board inspection
- Front Entrance revamp

  - Agreed to paint letters grey and center vertically
  - Shrubs in front of letters will be removed
  - Screening evergreen shrubs to be installed behind fences (5 on each side)
